Terms and Conditions

1. Setup/ Break Down: All Exhibitors must be set up and ready to sell by 10:00 am on 2/9/2019. Exhibitors may begin setting up at 8:00 am the day of the Fair. Break down can start no sooner than 3:00 pm on Saturday and must be completed by 5 pm. No vendor is to close before the official closing time. Sellers are responsible for their selling spaces. *Before leaving, be sure your area is clean and trash-free.
2. Exhibitor Responsibility: Exhibitor will be fully responsible for any loss or damage to his or her property by theft, fire or casualty. The RABC expressly disclaims any responsibility for same. Exhibitors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation. Each exhibitor is responsible for the conduct of his employees and/or representatives, and activities must not detract from the image or welfare of the fair.
3. Direct Sales: Only one vendor from each direct sales company will be allowed. Spaces are reserved on a first-come first-served basis.
4. Acceptance: The RABC reserves the right to decline any application for space if it deems such action to be in the best interest of the Vendor Fair.
5. Payment: The full payment is a non-refundable registration fee for the selected space and is due with the submission of this agreement.
6. Cancellation of space: Application fees are not refundable. The RABC is not liable if weather or other conditions prevent the Exhibitor from attending and fulfilling the contractual obligation as an Exhibitor. No refunds will be made the booth fee will be considered a donation.
7. Indemnification: Exhibitor agrees to indemnify and hold harmless The RABC from and against any loss, expense, claims, damages, causes of action, injuries, suits or damages, suits to person or property, including attorney's fees, arising out of or related to the operation of the Exhibitors at the RABC Vendor Fair.
